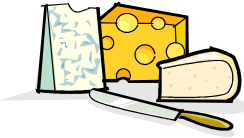


Beginner Cheesemaking Workshop

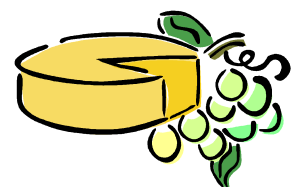
