Thank you for your interest in the 2017 Maine Cheese Festival! This event is both a fund-raiser for the Maine Cheese Guild and a promotion for all Maine cheese. The festival will take place at Savage Oakes Winery in Union, Maine on Sunday, October 15, 2017 from 11AM - 5PM. A fee is being charged to vendors in order to help cover the costs associated with the event.

It is our goal to feature cheeses from as many licensed Maine cheesemakers as possible. The festival will be promoted through advertising, social media, and press releases to food magazines, tour groups, the office of Maine Tourism, and MOFGA's Common Ground Fair, and as far-reaching as Boston to attract cheese lovers from all over! We are building on last year's event, offering a bigger festival with more activities and more volunteer staff to help everything move smoothly.

We have a limited number of juried spaces available for Maine made or Maine grown products that compliment cheese. Therefore, not all applicants will be accepted into the festival. We are also looking for foods that compliment Maine cheese. If you are a prepared food vendor who uses cheese, you must use Maine cheeses in your products. Some additional food will be provided for sale by Savage Oakes Winery. FYI - wine samples, wine-by-the-glass and bottles of Savage Oakes wine will be available for purchase on premises. Also, many festival goers enjoy picnicking during the festival, and many come ready to shop to take home delicious Maine cheese and other goods.

This event is **Rain or Shine**. We are limiting space to keep vendors proportional to the cheesemakers in attendance. We will work to spread our non-cheese vendors throughout the space for optimal placements. Once your application is accepted and approved, you will have two weeks to send payment and all fees are non refundable. Thank you for helping us celebrate Maine Cheese and Maine Cheesemaking!!
